The workshop also explores how MDTs can recognize and respond to spiritual injuries before, during and after the forensic interview.

Description: There is corroborating evidence in every case of child abuse, including cases of sexual abuse. Using actual vignettes, the presenter helps attendees see corroborating evidence that is almost always present but often missed. Working as team, students will learn to tear apart a child's statement and find the corroborating physical evidence in cases of child sexual abuse.

2. Learn to use photographs as corroborating evidence.
3. Learn to use corroborating evidence in the interviews and interrogations of suspects.

Victor Vieth

Victor Vieth, JD, MA, is the Director of Education and Research for Zero Abuse Project. In this role, he develops long-term strategy for expanding Zero Abuse Project and its programs nationally and internationally. He also teaches, publishes, creates programs and works on public policy issues related to child protection.

Victor is in demand as a nationally recognized expert in the field of interpersonal violence. He has trained thousands of child protection professionals from all 50 states, two U.S. Territories and 17 countries on numerous topics pertaining to child abuse investigation, prosecution and prevention. Victor has been instrumental in implementing 22 state and international forensic interview training programs and dozens of undergraduate and graduate programs on child maltreatment.

Victor gained national recognition for his work addressing child abuse in small communities as a prosecutor in rural Minnesota. He has been named to the President's Honor Roll of the American Professional Society on the Abuse of Children. The Young Lawyers Division of the American Bar Association also named him one of the "21 Young Lawyers Leading Us Into the 21st Century." Victor is regularly asked to consult with legislators around the country regarding policy and reform and has testified in front of the United States Senate. Numerous foreign countries, including Saudi Arabia, Russia, and Columbia, have sought his expertise to guide them as they create and implement ground breaking child protection policies.

Victor has published countless articles related to the investigation, prosecution and prevention of child abuse and neglect. He is author of "Unto the Third Generation," a bold initiative that outlines the necessary steps we must all take to eliminate child abuse in America in three generations.

Victor graduated magna cum laude from Winona State University and earned his juris doctor from Hamline University School of Law (HUSL). While studying at HUSL, he received the American Jurisprudence Award for achievement in the study of constitutional law and served as editor-in-chief of the "Law Review."

Analena Lunde

Dr. Analena M. Lunde is currently employed with the North Dakota Bureau of Criminal Investigation (BCI) Victim Services Unit (VSU) as a Victim Witness Specialist for the western region of North Dakota. She has over 25 years of critical care nursing, flight medicine, forensics, and public health experience which has facilitated her work in both the human trafficking, violent crimes, sex crimes, and commercial sexual exploitation fields.

Dr. Lunde serves as a board member and advisor on various local, state, and national human trafficking, Victims of Crime Advocacy organizations, public health, and forensic nurse councils, actively participating in policy development, education, and practice translation. In addition, Dr. Lunde assists the communities in her region with developing best practice response protocols for trafficking survivors and victims of crime with various task forces (Internet Crimes Against Children and Cyber Crimes Unit), US Attorney's Office, Department of Homeland Security, Federal Bureau of Investigation, Bureau of Indian Affairs, ND Bureau of Criminal Investigation, and local law enforcement to identify and prosecute traffickers and offenders. As a Forensic Nurse Examiner, she has been called upon to provide expert opinion/testimony for specific adult and pediatric trial cases.

Dr. Lunde has over 1000 hours in training in the field of victim assistance. She earned her Doctorate in Nursing Practice and has trained nationally for the McCain Institute and the National Network for Youth on issues related to Human Trafficking. She continues to teach public health and leadership/management courses in both the baccalaureate and associate degree for various nursing programs nationwide. Dr. Lunde is a member of the Western Region Child Abduction Response Team (CART) alongside a group of experts who respond to endangered, missing, or abducted children. She is a certified SHARP trainer (Sexual Health and Adolescent Risk Prevention) through the North Dakota State University and Planned Parenthood Department teaching youth how to reduce risky behaviors. She is a group facilitator for Ending the Game, an evidence-based "coercion resiliency" curriculum that reduces feelings of attachment to traffickers and/or a lifestyle characterized by commercial sexual exploitation, thereby reducing the rate of recidivism among sex trafficking survivors. She currently delivers this curriculum at the Dakota Women's Correctional Center.

Dr. Lunde was awarded the 2022 NDBCI Civilian of the Year Award for her victim-centered work with victims of crime and the 2021 Circle of Excellence Award from Education Affiliates for her work in public health and mentorship for young nurse graduates. She was also recognized by the North Dakota Department of Health as the 2021 Health Equity Champion for the Western region of the Dakotas for her community outreach and advisory board member work with the New American/Foreign born/Immigrant (NFI) Advisory Board.

Cassidy Halseth (and Jab)

Cassidy Halseth lives in Minot with his wife Christal. They have 8 children, three at home, and five that are out on their own, but not visiting home enough! Cassidy has been a Special Agent with the Bureau of Criminal Investigation and assigned to the Cyber Crime Unit since 2017. Prior to that S/A Halseth was a Detective and a Patrol Officer with the Minot Police Department from 2002 to 2017. Cassidy has been active in many things during his law enforcement career to include being a Certified Bomb Technician for the Minot Police Department for over 13 years, member of the Minot Police Department Bike Patrol Unit, President of the Minot Police Department Employees Union, President of the Special Operations Committee for the State of North Dakota, and a member of the Internet Crimes Against Children Task Force since 2012.



It was the joining of the Internet Crimes Against Children Taskforce that has forever changed S/A Halseth's career in law enforcement. Since 2012 S/A Halseth has specialized in cases involving the victimization and exploitation of children. S/A Halseth has completed all necessary training and has become a Certified Forensic Computer Examiner through the International Association of Computer Investigative Specialists and is certified in the use of several different forensic hardware and software tools. In January of 2023 S/A Halseth became the ICAC Commander for the state of North Dakota, overseeing over 100 task force members from over 50 affiliate agencies.



S/A Halseth is also a certified Electronic Detection K-9 handler. S/A Halseth attended the premier Electronic Detection K-9 school at Jordan Detection K-9 in Indianapolis, Indiana and was honored to be partnered with K-9 Special Agent Jab. S/A Halseth and Special Agent Jab now work side by side every day to catch child predators and work tirelessly to keep the children of our communities safe.

Jill Krone is a Victim Witness Specialist for Eastern North Dakota currently employed with the North Dakota Bureau of Criminal Investigation (BCI) Victim Services Unit (VSU) and is a member of the North Dakota Human Trafficking Task Force. Prior to her working for BCI, she was a Parole Officer for the State of North Dakota for 14 years and before that worked at the Clay Co Jail as a Correctional Officer for 8 years. Jill is a graduate from the University of Minnesota-Duluth with a Bachelor of Arts with a double major of Sociology and Criminology. She is also a Certified Brain Injury Specialist experienced in the epidemiology of brain injury and rehabilitation management.



Jill's work with the Human Trafficking Task Force, Cyber Crimes Unit, and Internet Crimes Against Children (ICAC) statewide teams includes, providing training, technical assistance, and crisis support for victims of crime to include exploitation and trafficking. In her role as a Victim Witness Specialist for the Bureau of Criminal Investigation (BCI) covering the Eastern region of North Dakota, Jill provides direct services to victims of violent crimes ensuring that the needs and the rights of crime victims and witnesses are met through compliance with the law, and with respectful, trauma-sensitive, and fair treatment.





Tammy Ness

Tammy Ness, LCSW, PLLC began her career in 1989 with William County Social Services as a child protection and foster care worker following graduation from Minot State University. In 1991 she returned to Minot to work on the Children and Family Unit at North Central Human Service Center as a child sexual abuse expert but also continued work with children and families around all mental health needs for youth. In 2004, Tammy returned to the University of North Dakota to obtain her Master of Social Work degree where she graduated in 2005. In 2013, she was promoted to Clinical Director on North Central Human Service Center until her retirement in February 2021.

Today, Tammy operates her own full-time private practice where she sees all age groups providing therapy for trauma, anxiety, depression, relationship issues using individual, group and couple modalities. Tammy is also the clinical consultant for the Northern Plains Children's Advocacy Center in Minot where she provides clinical supervision to the therapy staff and consultation to the agency director.
